## <u>Jeff Sanford – President:</u>

For 2009 the Falcon's Lea Patio HOA accomplished the following tasks:

- Book with approved color schemes to paint your house
- Remodeled the entire pool including:

**Diamond Brite** 

New tile around pool

**Energy efficient light inside the pool (LED Lights)** 

New pool deck

New fence / gate

New pool furniture

New pool signage

New light fixtures on poles around the pool area

**Electrical work done for the new lighting** 

The missing letters at the entrance were replaced. The wall was repaired from the car accident on Falcon's Lea Drive.

#### The Goals for 2010:

- Work on re-landscaping the common areas/entrance ways
- Fences:

- Any fences that need to be replaced along Falcon's Lea Drive will be given notices. As a courtesy, the Board will make contact with fencing companies to solicit quotes for replacement fences. The homeowner is ultimately responsible for the cost of replacing these fences and may use utilize whoever they wish to complete the work.
  - Paint: Work on painting the concrete wall along Falcon's Lea Drive.
  - Hire a Web Master to maintain the HOA website.

Robin motioned to hire a web master - Motion approved.

### Robin Burfeindt - Vice President:

2009 Notices that went out to homeowners:

Roofs: 33 house cleaned their roofs, 8 houses are in the process of filing a claim with their insurance company to replace existing roof (these homes were given a waiver on cleaning their roofs), and 16 homes were given extensions to clean their roofs until Jan. 31st, 2010.

Lawn Maintenance: 11 houses were given violation notices, 8 homes complied, 2 homes still have time to comply and the last home owner made written notice to the board.

Update on the Property located at 6251 Manchester Lane - The homeowner has made contact with the board in regards to the violation notices and has informed the board that she will be working on correcting the violation. Since homeowner made contact with the Board, any work previously scheduled to be completed on this property by the Board has been on hold. This will give the homeowner time to comply with the notices.

Tree Trimming: 2 houses were give violation notices, 1 complied and Lot 34 was given extension until Jan. 31st, 2010 to comply.

Light Poles: 10 houses were given notice to install new light poles (none on property), 9 houses complied, and one house was given extension until Jan. 31st, 2010 to comply.

3 Derelict Vehicles on properties were given notice: all 3 are in compliance (2 are gone and one has a car cover)

**Boat Violations:** 

Lot #116 was given notice to remove boat from front yard.. Complied 12/2/09

Lot #157 was given notice to place cover on boat...Has until Jan. 31st, 2010 to comply

Lot #133 - Owner is cleaning the garage and boat will be back in garage this weekend

**Commercial Vehicles:** 

Lot #122 was given notice and owner complied by placing a cover over this vehicle.
