## Jeff Sanford - President:

- Discussed changing the By-Laws for Falcon's Lea Patio and requested the input from the residence within the community.
- Discussed Broward Beautiful. A grant for homeowner associations that allows use of funds to improve the common areas within a development. The funds would have to be utilized in common areas that would not be restricted to the viewing public.
- Discussed implementing a Violation Fee on homeowners who do not maintain their property.

#### Christine Buckley - Treasurer:

- Announced the current balances in the accounts.
- Bills to be paid this month:

- Expanded on Broward Beautiful Grant.

## Heather Skinkis – Secretary:

- Discussed the 2" Overlay Process:
  - Seal Coating Slurry mix of sealer, cold tar emoltion spread by broom on entire driveway (Black in color) – Drying time: 1 Full Day
  - Overlay 2" of asphalt featured in over existing driveway Curing time: 3 – 10 days
  - Patching Hot asphalt, cut then spread in area in need of patching Curing time 3-10 days.
- Homeowners can still submit names for the 2" Overlay to the driveways.
- Notices will be going out for those homeowners that have not paid their association dues in the amount of \$350.00. Homeowners will have 30 days to pay their dues.

## Suggested Changes to the By-Laws:

- Multi color roofs, choices in colors
- Choices in types of roof materials Metal, cement tile, i.e.
- Driveways choices pavers, stamp concrete, asphalt
- Types and styles of fences allowed Wood, PVC or chain link
- Inserting a No Pitbull's clause
- Pole Lights need to be on every property & must be lit.

#### Homeowner's Concerns:

- Trash is being left on the street for a week or so until Bulk Pickup.
- Obtaining quotes for multi homeowners to obtain: pavers, asphalt or stamp concrete.
- For Sale By Owners signs within the common areas of the development should not be allowed. Any signage on a Lot or Unit needs to be approved by the HOA.
- Lamp Post within the homeowners property need to be lit.
- Locking of the pool fence needs to be addressed.
- Notices to Homeowners to make improvement to their properties: Roof cleaning, house painting, driveway, lamp post, etc. Concerns over notices due to water restrictions.
- Inquire if Marlon Luis is available to discuss issues involving our community.

- Pool has algae. Pool bathroom doors are broken.
- Make realtors aware of our Homeowner's By-Laws and hold realtors responsible.
