  - Sept. 18<sup>th</sup> was the first kick off meeting. Jeff, Heather and Christine attended along with several others from surrounding Ivanhoe Communities.

  - The study will take approximately 3 years to complete first. They will be having a sound engineer in the neighborhood over the next few months recording the decibels for the sound from I-75. It probably won't be for another 7 years before the wall is built unless we all continue to push the project up.

    - Please have cars parked overnight at pool removed. Same cars every night. – Have been monitoring. Haven't seen them, but will continue to monitor.
    - The condition of 6320 Plymouth Lane lawn cut (both front & back). Notice was given by the Association. It was cut, but will continue to monitor it.
    - 6110 Plymouth Doing business out of their house. Contact both the Town of Davie and Broward County. No license on file with either of them. Call Davie Code Enforcement when you see activity. That's all we can do for right now. Recommend: Association sending them a letter to advise them it's against our By-Laws with a copy of the Yellow Pages ad just to advise them that they cannot be doing business from their home and furthermore, that type of business does require a license from both Broward County and the Town of Davie.
